SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Avoid all direct contact with the spilled material. Refer to protective measures listed in sections 7 and 8. No action shall be taken involving any personal risk or without suitable training. If the product contaminates lakes, rivers, or sewers, inform the appropriate authorities in accordance with local regulations.

6.2 Environmental precautions

SECTION 7: Handling and storage

7.1 Precautions for safe handling

Avoid inhalation of vapour, dust and spray mist. Avoid contact with skin and eyes. Eating, drinking and smoking should be prohibited in area where this material is handled, stored and processed. Appropriate personal protective equipment: see Section 8. Always keep in containers made from the same material as the original one.

Never use pressure to empty; the container is not a pressure vessel. Always keep in the same material as the supply container. Good housekeeping standards and regular safe removal of waste materials will minimise risks of spontaneous combustion and other fire hazards. The Manual Handling Operations Regulations may apply to the handling of containers of this product. Packs with a volume content of 5 litres or more may be marked with a maximum gross weight. To assist employers the following method of calculating the weight for any pack size is given.
