5.3 Advice for firefighters

SECTION 7: Handling and storage

7.1 Precautions for safe handling

Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapour or mist. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

Never use pressure to empty; the container is not a pressure vessel. Always keep in the same material as the supply container. Good housekeeping standards and regular safe removal of waste materials will minimise risks of spontaneous combustion and other fire hazards. 8.2 Exposure controls

Appropriate engineering controls

All engineering control measures used to control exposure to hazardous substances must be selected, maintained, examined and tested to meet the requirements of the Control Of Substances Hazardous to Health regulations (COSHH). These requirements include the provision of any necessary information, instruction and training with regard to their use. Special precautions should be taken during surface preparation of pre-1960's paint surfaces over wood and metal as they may contain harmful lead.

Provide adequate ventilation. Where reasonably practicable this should be achieved by the use of local exhaust ventilation and good general extraction. If these are not sufficient to maintain concentrations of solvent vapour below the relevant workplace exposure limits, suitable respiratory protection should be worn. (See personal protection below). Dry sanding, flame cutting and/ or welding of the dry paint film will give rise to dust and/ or hazardous fumes. Wet sanding should be used wherever possible. The product has been assessed following the conventional method and is classified for toxicological hazards accordingly.
